TOURNAMENT RULES

Tournament Open to USBC Certified Women Only

1. Walk-ins permitted up to 15 minutes before start of tournament. Cash only. **MUST** have signed verification of average from league secretary. **NO EXCEPTIONS**
2. Tournament is open to **USBC Certified members only**. Membership dues in the Philadelphia 600 club of \$6.00 must be paid in order to participate in the Tournament. Entry forms will be returned if membership is not current. New applicants wishing to join and bowl will be accepted the day of the tournament. (All verification of averages and membership will be checked by secretary on/and day of the tournament).
3. Tournament shall be conducted on a scratch basis and handicap basis. The handicap shall be 80% of 220. Highest league average of the previous season in any USBC Certified sanctioned league, 21 games or more shall constitute an average. A bowler not having a previous season's average shall use summer average of 12 games or more from any USBC Certified sanctioned league. Closing date for summer average is August 31, 2022. Any bowler not having an established average shall bowl with a scratch average of 220.
4. The tenpin increase of **USBC Certified (provision 319-A2)** will **not** be applied in this tournament. **USBC Certified (rule 319-D)** requiring an entrant to report any previous tournament prize winnings as a condition for entry will **not** apply. **Rule 319-E is waived.**
5. All averages are subject to verification by the local association secretary. Failure to use the correct average shall disqualify the scores if submitted average is lower than the correct average.
6. No fees returned except in an emergency, 48 hours prior to the tournament.
7. Entrants in this tournament do so at their own risk of personal injury. The host lanes and the Philadelphia 600 Club shall not be liable for loss of personal property or personal injury received by a participant during and traveling to and from this competition.
